APPLICANTS ARE RESPONSIBLE TO PROVIDE REQUIRED INFORMATION AND DOCUMENTATION. ASSISTANCE COMPLETING AN APPLICATION IS AVAILABLE UPON REQUEST. THE COUNTY HAS 14 DAYS FROM RECEIPT OF A COMPLETED AND IDENTIFIABLE APPLICATION TO DETERMINE ELIGIBILITY. APPLICANTS HAVE THE RIGHT TO APPEAL ELIGIBILITY DECISIONS WITHIN 30 DAYS FROM RECEIPT OF WRITTEN NOTIFICATION OF INELIGIBILITY.

JASPER COUNTY WILL ONLY ACCEPT AND PAY THE STANDARD PAYMENT RATES AS DETERMINED BY THE DEPARTMENT OF STATE HEALTH SERVICES. THESE PAYMENT RATES APPROXIMATE MEDICAID RATES.

JASPER, TEXAS IS PART OF A HOSPITAL DISTRICT. THEREFORE, JASPER COUNTY RESIDENTS, WHO RESIDE IN THE SERVICE AREA OF THE HOSPITAL DISTRICT, ARE PRESUMED TO BE A RESIDENT OF THAT DISTRICT. YOU MUST APPLY THROUGH THE INDIGENT OFFICE AT CHRISTUS JASPER MEMORIAL HOSPITAL. CALL 409-384-5461 FOR ASSISTANCE.
