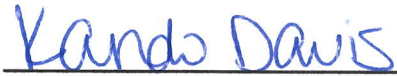

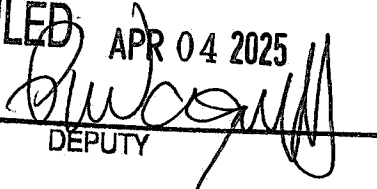

2. Court to consider approving the Jasper County Historical Commission's recommended board changes which also include adding Lindsey Cox and Druscilla Miller to the board, and take any appropriate action.
3. Court to consider and approve authorizing GLS to go out for bids on the GLO-CDBG-MIT grant for the Homer building, and take any appropriate action.
4. Court to consider renewing Jasper County's property and liability insurance coverage, and take any appropriate action.
5. Court to discuss providing in-kind site preparation and parking lot construction assistance at the proposed law enforcement and fire training facility location on U.S. Highway 190 in a partnership with Jasper ISD, Deep East Texas College & Career Alliance, ESD #4 and the City of Jasper, and take any appropriate action.
6. Court to consider accepting a donation in the amount of \$1,000.00 from the Christus Jasper Memorial Hospital Auxiliary on behalf of the Sheriff's Office, and take any appropriate action.
7. Court to consider accepting a donation of \$200.00 from Renee O'Carolcess of Woodville on behalf of the Sheriff's Office for the K-9 program, and take any appropriate action.
8. Court to consider authorizing the Sheriff's Office and Constable's Offices to trade in seized or county-owned firearms to acquire new weapons for law enforcement purposes, and take any appropriate action.
9. County Clerk Holly Thomas to address the Court with a request to utilize records preservation funding to scan and digitalize all remaining deed records, and the court to take any appropriate action.
10. Court to consider adopting a policy regarding airport courtesy car availability and services for Jasper County's Bell Field Airport, and take any appropriate action.
11. Court to consider accepting bids and awarding contracts for road and bridge materials, oil, tires, tubes, pipe, culverts, maintenance supplies, and take any appropriate action.

12. Court to consider correcting the District Attorney's Executive Assistant partial payroll adjustment to come from the state prosecutor's grant line instead of the SB22 grant fund, and take any appropriate action.
