- 7. You are a member of the United States military forces serving on active duty and deployed outside of Jasper County.

- 5. You are not of sound mind and good moral character.
- 6. You are not able to read and write.

- 9. You are under indictment or other legal accusation for misdemeanor theft or a felony theft.
- 10. You have served as a juror for six days during the preceding three months in the county court or during the preceding six months in the district court.

Right to Reemployment: An employer may not discharge, threaten to discharge, intimidate, or coerce any permanent employee because the employee serves as a juror, or for the employee's attendance or scheduled attendance in connection with the service, in any court in the United States. (Civil Practice and Remedies Code, Section 122.001).

Failure to Answer Summons: In addition to any criminal penalty prescribed by law, a person who fails to comply with this summons, or who knowingly provides false information in a request for an exemption or to be excused from jury service, is subject to a contempt action punishable by a fine of not less than \$100 nor more than \$1,000 (Government Code, Section 62.0141).
